

In 1974, the
Committee on
World Food
Security (CFS) was
established; It is
the UN forum that
reviews and follow
up policies
concerning Food
Security.

Members include the World Food Programme and IFAD. Secretariat based in Rome. * Broad based consultation; RAI was eventually approved in 2014.

* Through the CSO for CFS mechanism where AsiaDHRRA was active participant in the process.

Why is RAI relevant?

Critical issues:

- Poverty in the rural areas
- Challenge for food security

Yet, We are not investing enough in agriculture.

We need to invest MORE in agriculture.

On the other hand, investment may lead to negative results e.g. destruction of environment,

Not only more investment: but better investment

The CSF guidelines on RAI was adapted by ASEAN based on its regional context – that is why we have the ASEAN Guidelines on Responsible Agricultural Investment (AGRAI)

| | 9 | Governance and Grievance Mechanism | Assess and address impacts and promote accountability |
| | 10 | Impact and Accountability | Strengthen regional approaches to responsible investment in FAF in ASEAN |












We need to give attention to Young Farmers,

and empowerment of Women in Agriculture

Young people do not want to engage in agriculture because of the notion that it has no future.

The agricultural sector needs to rejuvenate to increase global food production by 60% by 2050



Successful young agrientrepreneurs will create livelihood opportunities and hence reduce unplanned and distress rural-urban and international migration.

Empowering youth, including farmers, agri-entrepreneurs and workers who are mostly women, to engage in agriculture; investment helps reduce unemployment











The RAI Project

RAI is an advocacy initiative. It aims to disseminate information on importance of RAI principles; to engage policy makers to integrate RAI in current policy frameworks; and encourage CSOs and Private Sectors (to adhere to) and promote RAI.

Responsible investment in agriculture and food systems refers to the creation of productive assets and capital formation, oriented to support the realization of food security, nutrition and sustainable development, including increased production and productivity.

It requires respecting, protecting and promoting human rights, including the progressive realization of the right to adequate food and other relevant human rights instruments.











Update on Implementation of RAI Project

From December 2019 to September 30, 2020, these are the achievements of the project:

- 1. Capacitated 24 members of DHRRA networks as Trainers on Capacity Assessment for RAI and Youth in Agricultural Sector:
- 2. Developed materials for information dissemination e.g. Monograph on the Principles of Responsible Investment in Agriculture and Food Systems (CFS-RAI); procured copies of the ASEAN Guidelines for Responsible Investment in Food, Agriculture and Forestry (AGRAI) from GROW ASIA and distributed to national partners;
- 3. Disseminated and popularized RAI info through Webinar: Asian Family Farmers and Covid 19: Impact, Innovations, and Investment on July 21, 2020

Developed mapping study describing in general terms relevant laws, policies and programs related to RAI and the general situation of youth in agriculture;


RAI targets for the remaining period – on going activities

Build constituency for RAI



Way Forward in 2021

Partnership of AsiaDHRRA and FAO shall continue in 2021 with a new partnership agreement now in the pipeline. It will involve expanded advocacy objectives at the country level and with focus on Youth and Women in agriculture; and culminating with a regional process.

The RAI initiative will contribute to actualize the existing MOU of AsiaDHRRA with FAO.
